3. Description of goods, services or construction:

An Anesthesia Services Management Company that will provide anesthesia services at Hilo Medical Center. These services will include delivery of anesthesia service for inpatient and outpatient procedures, twenty-four hours daily, every day of the year. This includes but is not limited to provision of anesthesia in the Operating Suite and Cesarean Section suites as well as care for the Emergency Department, Intensive Care Unit, and Interventional Cardiology.

8. Explanation describing how procurement by competitive means is either not practicable or advantageous to the State:

Hilo Medical Center executed a fully competitive Request for Proposal process in 2018 for anesthesia services resulting in the award of a contract in August 2018. The current contractor has just tendered a letter exercising their right to termination of contract without cause as of April 3, 2020. The previous RFP for anesthesia services took eight months to complete and the fastest the Hilo Medical Center could complete a fair, open and competitive RFP for services is six months. Following an RFP process would leave HMC without an anesthesia management group for up to four months.

Hilo Medical Center conducts 4,500 surgeries requiring anesthesia each year and provision of these services requires 7 full time equivalent anesthesia providers. Hilo Medical Center does not have the resources or expertise to provide for recruitment, retention, scheduling and quality assurance for a group of anesthesiologists this large. For this reason, HMC needs to contract with an established anesthesia management company immediately to assume provision of care by April 3, 2020.

9. Details of the process or procedures to be followed in selecting the vendor to ensure maximum fair					
and open competition as practicable:					
After receipt of the termination notice from the current vendor, Hilo Medical Center requested and received proposals for anesthesia services from two vendors available to provide the services on short notice, LifeLinc and Island Professional Anesthesia within the very short deadline needed to ensure continuity of anesthesia services. Both proposals were thoroughly reviewed by administrators at Hilo Medical Center including the CEO, the Chief Medical Officer, The Director of the Operating Room and contracts. Island Professional Anesthesia was selected as the company most qualified to meet our immediate need for services. The contract with Island Professional Anesthesia will be for a two year period with an option to renew for two additional years.					
The two year contract period is the industry standard for initial award of an anesthesia contract as that length of time is needed to recruit appropriate personnel, implement quality improvement programs, and offset initial startup costs.					
10. A description of the agency's internal controls and approval requirements for the exempted procurement:					
Hilo Medical Center has an Executive Management Team engaged in developing the content of the exempted contract. This team includes, the CEO, CFO, CMO, Director of Nursing Services, Medical Director of Acute Care and the Operating Room supervisor. The entire process will be overseen by our Contract team and our Compliance Officer.
